

VOTE FOR GARY SCHMIDT THE REAL REPUBLICAN FOR SENATE SEAT 16. KICK OUT BEN "TAX'EM AGAIN" KIECKHEFER THE "FAKE" REPUBLICAN.

THE CENTER FOR PUBLIC INTEGRITY CITES BEN KIECKHEFER'S CONFLICTS OF INTEREST WHILE RATING NEVADA FIFTH MOST CORRUPT STATE IN THE NATION!!

Recently besieged candidate Gary Schmidt for State Senate District 16 has long championed the Legislature should comply with the OML and for mandatory recusal of State Legislators from voting on issues where they have such conflicts of interest as Kieckhefer.

If you Google Ben Kieckhefer corruption and conflict of interest you will get The Center for Public Integrity reports that talk extensively about Kieckhefer and his CONFLICTS in the Nevada Legislature related to his day job employment with the notorious lobbyist law firm of McDonald Carano and the appearance of his "office mates" before him at legislative hearings lobbying for legislation and Kieckhefer's voting on those measures without even disclosing that he knows the lobbyist testifying, let alone that he works in his regular job side by side with them. This may be a crime in many States but not here in Nevada.

Schmidt states; "Transparency is essential to conduct representative government and to maintain confidence in elected officials by their constituents. Nevada is currently a Good Old Boy State essentially run by a group of anointed political class elitists and special interests where any distinctions between the Republicans and Democrats, among the preordained elected officials, is blurred by their allegiance to the establishment."

Schmidt has been the target of Senator Kieckhefer and the Offices of the Nevada Secretary of State and the Nevada State Attorney General who have attempted to disqualify him from running against Kieckhefer for the Senate 16 seat. Based upon dubious claims by Kieckhefer, in regards to Schmidt's residency, Carson City District Court Judge Wilson; who has received campaign "assistance" arranged for by Kieckhefer, recently ruled against Schmidt in the matter. Schmidt appealed to the Nevada State Supreme Court and they have Stayed the lower court Order declaring Schmidt "eligible" to run for the Office. Early voting started on May 26 just one day after the Nevada State Supreme Court Order that put Schmidt back in the campaign; the election concludes on June 12th.

Schmidt has declared; "The State Supreme Court has struck a blow against the NEVADA SWAMP and back room good old boy corrupt establishment politics. The people have been granted the right to choose Schmidt as their Republican candidate for State Senate District 16."

Maurice White, former Chairman of the Carson City Republican Party and supporter of Schmidt's candidacy for State Senate 16, attended the lower court hearing and stated; "The law in this instance is very clear and simple. This fake SLAPP suite instigated by Kieckhefer serves no purpose other than to suppress the right of the people to have choice at the ballot box. I am aghast at Kieckhefer's unwillingness to face a credible opponent in this contest for the peoples seat in Nevada Senate District 16. If for no other reason, and there are plenty, we should reject Ben Kieckhefer as our Nevada Senator for District 16."

Is the Secretary of States Office guilty of Election Law Violation and Malfeasance in bias against Schmidt ??? Malfeasance and bias for Kieckhefer was again shown by the Office of the Secretary of State (and the office of the

Attorney General) against insurgent Candidate Schmidt in Senate 16 who promises to work hard on Draining the Swamp. !! The Secretary of States (SOS) Office failed to abide by an Order from the Nevada State Supreme Court issued early Friday afternoon (5/25/18) STAYING a lower court order against Schmidt's candidacy for Senate 16. The lower court order had been based on dubious accusations by Kieckhefer in regards to Schmidt's residency.

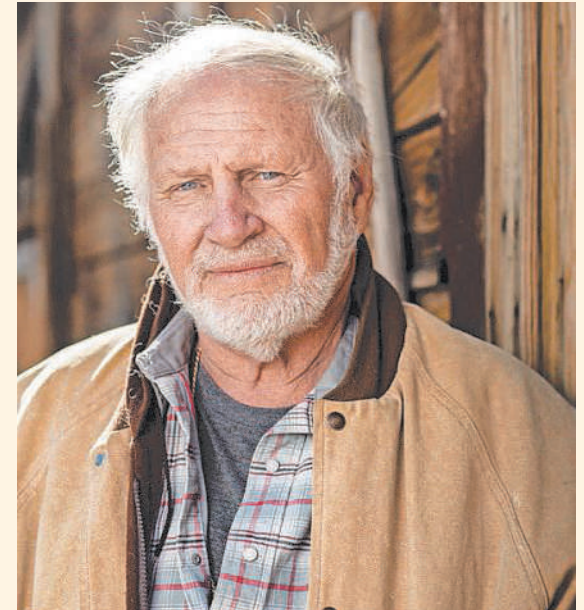
In defiance of and in violation of the Nevada State Supreme Court Order, issued Friday May 25, 2018, the SOS's office continued to list Schmidt as a "disqualified candidate" throughout the first three days of the early voting period. The SOS remained in violation of the Nevada Supreme Court Order declaring Schmidt a viable candidate until the SOS's office was confronted with a hand delivered election law violation complaint against the SOS filed at Tuesday May 29th. At that point the SOS's office acquiesced and complied with the upper courts order removing the "disqualified" notation. They have also failed to list Schmidt's website and other contact information. Several thousand people are reported to have voted over the holiday weekend. Those that relied on the SOS web site would have thought Schmidt ineligible to hold the Office. An FBI investigation of the SOS's failure to timely comply with the Nevada state Supreme Courts Order has been requested. Schmidt stated; "This is just another example of the ESTABLISHMENT going to do to try to spoil and steal this election ?"

"IT IS TIME TO DRAIN THE SWAMP!!"

David Omara, Schmidt's attorney, has demanded an explanation and a Press Release from the SOS about the obvious and grievous injustice. Omara stated; "Holding public office is a valuable right of citizenship and should not be prohibited or curtailed. By issuing a stay of the District Court's decision today, the Nevada Supreme Court has protected Mr. Schmidt's right to hold office and guaranteed the elector's right to vote for their candidate of choice in the upcoming primary election. Mr. Schmidt continues to maintain he is eligible to run and hold office as Nevada's Senator in District 16. He looks forward to being vindicated by the Nevada Supreme Court and then representing to citizens of his district during the 2019 Legislative session. The Court's decision today is a victory for all Nevadans."

Schmidt said: "I hope to bring this matter of "Contempt" before the State Supreme Court in July. This whole residency challenge brought about by Kieckhefer and supported by Swamp Creatures inside the Deep State of the Governmental Bowels was just a thinly veiled attempt to silence the voices of the PEOPLE." "As to the residency issue, I have owned property, conducted business, and lived inside the District for over 46 years. That is five years longer than Ben has been alive. I was attending hundreds of Community and Public Meetings here while he was still in diapers outside of Chicago !!"

Also of note is that some days after the lower court ruling against Schmidt, Kieckhefer donated from his Campaign Fund, raised from Special Interests, \$4000.00 to the Laxalt For Governor Campaign. You know, Adam Laxalt, the current Attorney General who brought the action against Schmidt, based on a dubious complaint filed by Kieckhefer,



before a District Court Judge that Kieckhefer had arranged campaign "assistance" for. The judge did disclose the "assistance" AFTER THE HEARING HAD ALREADY BEGUN. Kieckhefer is "Friends" with State Senator Roberson a candidate for Lieutenant Governor. Laxalt and Roberson have endorsed each other and are running TV ads together. Roberson and Kieckhefer both voted for the Commerce Tax. Schmidt is campaigning to repeal the Commerce tax.
